OLD BUSINESS

1. Public Hearing Ordinance 3 of 2015 - An Ordinance Amending Chapter 19, Section 23 of the Code of Ordinances of the Town of Blanchard, Adopting New Standards for the Issuance and Administration of the Building Permitting Process in the Town of Blanchard, as well as the Enforcement of the Construction Code therein, and otherwise providing with respect thereto.

3. 6. Public Hearing Ordinance 5 of 2015 – An Ordinance to Amend the Budget for the Town of Blanchard for the Fiscal Year Ending June 30, 2015, and otherwise Providing with Respect Thereto.
7. Vote on Ordinance 5 of 2015.
8. Public Hearing Ordinance 6 of 2015 – An Ordinance to Adopt the Budget for the Town of Blanchard for the Fiscal Year Ending June 30, 2016, and otherwise providing with respect thereto.
9. Vote on Ordinance 6 of 2015.
