CHAPTER 25

CRIMES AND OFFENSES

SECTION 25.1 CRIMINAL CODE ENACTED.

There is hereby adopted by this municipality that certain code entitled and revised 1991 "A Model Criminal Code" for the Town of Blanchard, having been adopted originally by **Ordinance No. 1 of 1980**, and which ordinance is incorporated herein by reference, except that Section 17.24 of this Code shall prevail over any contrary provision of Ordinance No. 1 of 1980. **This section revised as of April 14, 1992**.
