Public Hearing on Resolution 4 of 2016- BE IT RESOLVED, by the Town of Blanchard of the Parish of Caddo, Louisiana, in a public meeting held on August 9, 2016, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the following **adjusted** millage rates be and they are hereby levied upon the dollar of the assessed valuation of all property subject to ad valorem taxation within said Parish for the year 2016, for the purpose of raising revenue:

2. Public Hearing on Resolution 5 of 2016- BE IT RESOLVED, by the Town of Blanchard of the Parish of Caddo, Louisiana, in a public meeting held on August 9, 2016, which meeting was conducted in

accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the taxing district voted to increase the millage rate(s), but not in excess of the prior year's maximum rate(s), on all taxable property shown on the official assessment roll for the year 2016, and when collected, the revenues from said taxes shall be used only for the specific purposes for which said taxes have been levied. Said millage rate(s) are:

New Business

1. Adopt Adjusted Millage Rates as set forth in Resolution 4 of 2016 by Roll Call Vote.
2. Set Forth the Adjusted Millage Rates and Roll Forward to Millage Rates Not Exceeding the Maximum Authorized as set forth in Resolution 5 of 2016 by Roll Call Vote.
3. Motion, second, and vote on setting water rates for schools in a special billing category to be labeled "schools."
4. Motion, second, and vote on setting the current water rate for schools to \$173.10 for the minimum to 30,000 gallons and over 30,000 gallons the cost would be \$7.78 per 1,000 gallons.
