Introduction by Title Only Ordinance 9 of 2017 - An Ordinance to enlarge the limits and boundaries of the Town of Blanchard, Louisiana of the property described as a tract of land located in Section 26, Township 19 North, Range 15 West, containing 0.596 acres, more or less, Caddo Parish, Louisiana, and otherwise providing with respect thereto.
